A company with great respect the confidential (personal) information each and every person who visited the site and those who use the services provided by the Site in connection with which the Company seeks to protect the confidentiality of personal data (data or aggregate data about an individual who is identified or can be specifically identified), thereby creating and providing the most comfortable conditions of use of the Site services each user. Collection and use of personal data

When using the service user company site process the user data, such as: - data provided by the user as the application form, and in the process of using the service; - cookie files; - IP address; - parameters and settings Internet browser (User-agent). The company collects only personal information (such as your name, username and password, email address, contact telephone number, date of birth, gender, etc.) that are knowingly and voluntarily provided by you as a subject personal data in order to use the services of the Site in accordance with the law is the consent of personal data subject to the processing of their personal data in accordance with this Policy formulated in objective processing. When visiting the site records all inputs to the system. More information on user traffic is not processed and is not stored. Please note: Company limited by collecting the minimum amount of information required solely for the query subject of personal data. In any case, when requested to provide optional information, the user will be informed at the time of collection of such information. The company does not collect any information, to the processing of which, by law established certain requirements, such as information about racial or ethnic origin, political, religious or philosophical beliefs, membership in political parties and trade unions, sentenced to criminal punishment of a crime, and data concerning health, sexual life, biometric or genetic data (according to Article 7 of the Law of Bulgaria "On personal data protection"). Processing of personal data

Child safety

Privacy of personal data subject's activity on the site

Protection of personal data

The Company uses generally accepted standards of technological and operational protection of information and personal data from loss, misuse, alteration or destruction. However, despite all efforts, the Company can not guarantee absolute protection against any threats that arise beyond the regulation of the Company. The company provides the use of all relevant obligations regarding confidentiality and technical and organizational security measures to prevent unauthorized or unlawful processing or disclosure of such information and data of accidental loss, destruction or damage. The company provides access to information and personal data only to authorized employees who have agreed to ensure the confidentiality of such information and data in accordance with the requirements of the Company.

Conditions of access to personal data

The procedure for access to personal data of third parties is determined by the terms of consent given by the holder of personal data processing on the data, or in accordance with law. The user has the right to receive any information about themselves in any related entities connected with personal data provided an indication of the surname, name, place of residence (location) and details of the document identifying the individual who submitted the request, except when required by law. User access to the data itself is free of charge. Postponement user access to their personal data is not allowed. Delaying access to personal data of third parties is permitted if the required data can not be provided within thirty days of receipt of the request. The total term issues raised in the request may not exceed forty-five days. Notification of delay communicated

to a third party who has filed a request in writing explaining the procedure of appeal. The decision to delay or denial of access to personal data can be appealed to the Verkhovna Rada of Bulgaria on Human Rights or the court.

Rights subject of personal data

The company be informed about your rights as a subject of personal data are regulated by the Law of Bulgaria "On Personal Data Protection", namely:

- 1) know the source collection, the location of their personal data, the purpose of processing, location or residence (stay) or the holder of a personal data or give an instruction to obtain this information, authorized persons, except in cases established by law;
- 2) obtain information about the terms of access to personal data, including information about the third party who transmitted their personal data;
- 3) access to their personal data;
- 4) receive no later than thirty days from the date of receipt of the request, except as provided by law, the answer to whether his personal data are processed and receive the contents of such personal data;
- 5) present a reasoned request of the holder of personal data from negation to the processing of their personal data;
- 6) present a reasoned request to change or deletion of their personal data by any holder and manager of personal data, if these data are processed unlawfully or unreliable;
- 7) on the protection of their personal data from unlawful processing and accidental loss, destruction, damage due to deliberate concealment, failure to provide or untimely provision of and protection from providing information that is false or defaming the honor, dignity and business reputation individual;
- 8) apply with complaints about the handling of their personal data to the Verkhovna Rada of Bulgaria on Human Rights or the court;
- 9) apply remedies for violation of legislation on protection of personal data;
- 10) make reservations concerning the restriction on the processing of their personal data during its consent;
- 11) to withdraw consent to the processing of personal data;
- 12) know the automatic processing of personal data;
- 13) for protection against automated solution that has legal consequences for him.
